Subject:	One-Year Renewal Contract for Heavy-Duty Automotive Body Repair Services for the Fleet Services Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Renewal Contract for Heavy-Duty Automotive Body Repair Services as recommended.

The Fleet Services Department and Purchasing recommend authorizing the renewal contract with Rush Truck Center – Phoenix; Vanguard Truck Center; Freightliner of Arizona; and MAACO Collision Repair (a Mesa business); at \$150,000 00, based on estimated requirements.

Background / Discussion

On September 26, 2013, the City solicited Request for Qualifications to establish a qualified vendor list of pre-qualified automotive body repair firms to provide non-exclusive repair service, on an as needed basis. The awarded vendors are pre-qualified to provide all labor, tools, materials, garage facility and insurance to perform body and related mechanical repair work for the City's fleet of approximately 300 heavy duty trucks.

The City requests repair estimates on an as needed basis from the qualified vendor list. The qualified vendors are given an opportunity to provide an itemized quote for each heavy-duty truck body repair required by the City. The repair work is awarded to the lowest priced, responsive, responsible repair estimate submitted.

On May 19, 2014, Council approved the initial three-year contract with two, one-year renewal options. This is the first, one-year renewal contract with a one-year renewal option remaining.

All four vendors (Rush Truck Center – Phoenix; Vanguard Truck Center; Freightliner of Arizona; and MAACO Collision Repair (a Mesa business), offered to renew the contract without a pricing increase. The City has been satisfied with each vendor's performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

Fiscal Impact

The annual contract amount is available in the Fleet Services Department operating budget through the Fleet Internal Services Fund.
