Subject:	Purchase of Network Equipment for the Mesa Public Libraries as requested by the Library Services Department (\$219,447.94 – 80% funded by the E- Program and \$54.861 .98 – 20% funded by the Information Technology Department operating budget.) <b>(Citywide)</b>

#### **Purpose and Recommendation**

Council is requested to approve the contract for the Purchase of Network Equipment for the Mesa Public Libraries as recommended.

The Library Services Department and Purchasing recommend authorizing the purchase with the lowest, responsive and responsible bidders, Sentinel Technologies, Inc. at \$256,464.42; and ManCom Inc. at \$17,845.50; for the total purchase of \$274,309,92.

#### **Background / Discussion**

Cisco Ethernet switches, Ruckus wireless access points and uninterrupted power supply (UPS) equipment are used to support wired and wireless network connectivity at all City of Mesa library locations (Main, Dobson Ranch, Red Mountain and Express). The existing wired network connectivity is end of sale and out of product and maintenance support. The existing 802.11n wireless connectivity is being replaced to newer 802.11AC wave 2 technology which is a performance increase from 450Mbps to 2.3Gbps. The existing wired and wireless equipment will be replaced and retired.

The Universal Service Schools and Libraries Program, commonly known as the E-Rate Program helps ensure that schools and libraries obtain high-speed Internet access and telecommunications at affordable rates. The process starts with competitive bidding for the services needed and then selection of the most cost-effective provider. Upon contract execution, the Universal Services Administrative Company's (USAC) issues the funding commitment and the applicant starts receiving discounts on the services USAC has approved.

Library Services completed a formal bid process and vendor selection contingent upon Council approval of the E-Rate Program funding. The City filed the e-rate application on 7/21/2016 and received a funding commitment decision letter (FCDL) on 4/12/2017; the E-Rate Program will fund \$219,447.94 (80%) to replace the Mesa Public Libraries wired and wireless connectivity.

### Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

## **Fiscal Impact**

This purchase is 80% (\$219,447.94) funded by the E-Rate Program and 20% (\$54.861.98) funded by the Information Technology Department operating budget.
