Subject: Purchase of Three Replacement Rollback Trailers for the Transportation

Department (Funded by Local Streets Sales Tax) (Citywide)

Recommendation

Council is requested to approve the award as recommended.

The Transportation Department and Purchasing recommend authorizing the purchase using the National Joint Powers Alliance contract with Empire Southwest (a Mesa business) at \$176,764.77.

Background / Discussion

The Transportation Department is requesting replacement of three aging equipment trailers that are at the end of their service life. All three existing trailers no longer meet Transportation's needs due to their limited size and outdated electric braking systems. To improve safety, Fleet Services and Transportation are working to convert Transportation's trucks and trailers to air brake systems. After researching Transportation's needs, staff determined the Trail King Rollback Trailer (TK50RB) meets the needs and safety requirements for transporting the large, state-of-the-art equipment required to perform street and right-of-way maintenance.

The National Joint Powers Alliance (NJPA) contract was competitively bid, meets procurement requirements and prices are competitive due to nationally based volume contract pricing. It is unlikely that competitive bidding would result in better pricing than through this cooperative contract. Mesa is eligible to utilize this contract as a NJPA cooperative member.
