Subject: Term Contracts for Landscape Maintenance Services for Parks, Retention

Basins and Sports Fields – Zones 1, 2, 3 and 4 for the Parks, Recreation and

Community Facilities Department (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Parks, Recreation and Community Facilities Department (PRCF) and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the highest scored proposals from Mariposa Landscape Arizona, Inc.; Zone 1 at \$1,435,319.57 annually; Zone 2 at \$959,183.45 annually; Zone 3 at \$974,364.20 annually; and Zone 4 at \$1,221,738.22 annually; based on estimated usage.

Background / Discussion

These contracts provide landscape maintenance services for sports fields, parkways, medians, parks, retention basins or grounds adjacent to City facilities. Tasks performed include, but are not limited to: cleaning, irrigation, sprinkler system maintenance, trimming, mowing, weed control, fertilization, etc., depending on whether the area is turf, desert, or a combination of both.

The City has divided the landscaping into geographic areas known as Zones 1, 2, 3 and 4. A landscaping maintenance services contract for all applicable parks, retention basins and sports fields will be established for each Zone.

Zone 1 encompasses 403.32 acres of parks land and 163.73 acres of retention basin land between Power Road and Meridian Drive. Zone 2 encompasses 206.62 acres of parks land and 122.75 acres of retention basin land between Power Road and Val Vista Drive. Zone 3 encompasses 172.88 acres of parks land and 80.78 acres of retention basin land between Val Vista Drive and Stapley Drive. Zone 4 encompasses 313.44 acres of parks land and 32.01 acres of retention basin land between Stapley Drive and Price Road.

Staff from PRCF and Purchasing evaluated the proposals based on the evaluation criteria as stated in the solicitations. The highest scored and most qualified proposal for each Zone, 1, 2, 3 and 4, Mariposa Landscape Arizona, Inc., is being recommended for award. The evaluation committee unanimously agreed on the recommendation.

PRCF has done an analysis to bring the work under this contract in-house and at this time, contracting continues to be in the best financial interest of the City.
