Manager of Downtown Transformation Jeff McVay introduced Tony Wall, 3W Management President; Jenny Poon, CO+HOOTS Founder; and Odee Domingo, CO+HOOTS Co-Founder who discussed item 6-f (Approving and authorizing the City Manager to enter into First Amendments to the Development Agreement, Ground and Air Lease, and License Agreement with 3W Management, LLC, to facilitate the development of, and job creation and retention at, the City-owned property generally located at the southwest corner of Main Street and South Pomeroy and 34 South Pomeroy, which is the development commonly known as The GRID. (District 4)) on the Regular Council Meeting agenda.

Ms. Poon explained that CO+HOOTS is a co-working space for entrepreneurs. She noted that CO+HOOTS houses approximately 250 entrepreneurs and small businesses, as well as 175 different companies located in central Phoenix. She pointed out that CO+HOOTS assists the community by supporting high school students into college with the partnership of Benedictine University as well as underrepresented communities to pursue entrepreneurship. She pointed out that CO+HOOTS offers free programs, meet-up groups, and networking groups to connect other entrepreneurs and businesses within the City.

Mr. Wall remarked that the partnerships between the City of Mesa, 3W Management, CO+HOOTS, and Benedictine University is a tremendous step toward an Innovation District.

Mayor Giles thanked them for the presentation.
