Presentation on the effects of the COVID-19 Pandemic on the Parks, Recreation and Community Facilities Department

Marc Heirshberg, Director, presented a PowerPoint presentation to the Board on the effects of COVID-19 on the Department.

At the end of the presentation, the floor was opened for questions; Ms. Glasser asked about status of Mesa Public Schools and how that would impact our school-based programs, Mr. Heirshberg stated that Mesa Public Schools would start August 4th online, with more information on July 14th. Currently staff are on stand-by and are awaiting information. Currently we are providing take and make projects at 3 of the Recreation Centers. Ms. Orchidia Peterson wanted to extend her appreciation for the take and make bags and for the camps staff are able to do. Ms. Glasser stated that she has been impressed with the ability for staff to continue to do things online. Mr. Erickson also mentioned all the online adaptive programs staff are doing, multiple

classes during the week and how much that is helping participants and parents in those adaptive programs.

Director's Comments

Mr. Heirshberg provided a Project Update:

- Mesa City Center Plaza is moving along, it is currently in the design phase.
- North Center Street, archeologic studies are continuing.
- Monterey Park, staff have been focused on purchasing a 5-acre parcel, but due to owners asking price, staff is currently moving forward without that parcel of land.
- Red Mountain Center project the current lake will be enough to water the additional property. The design project is moving forward, and a public meeting will be held sometime in the future.
