A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, EXTINGUISHING A PUBLIC UTILITIES AND FACILITIES EASEMENT, AND VACATING A RIGHT-OF-WAY, LOCATED AT 4901 SOUTH ELLSWORTH ROAD.

WHEREAS A.R.S. § 28-7201 *et seq.* provides that the governing body of a city or town that holds a right-of-way easement for roadway (public street, highway, alley, lane, parkway, avenue, road, sidewalk or other public way) or owns public roadway may dispose of the roadway or extinguish the easement by resolution.

WHEREAS Mesa City Code Title 9, Chapter 10 permits the City Council to dispose of unnecessary public roadways and to extinguish easements no longer needed by the City.

WHEREAS, the City Council has determined that a Public Utilities and Facilities Easement, on the Map of Dedication for South Ellsworth Road, in Book 1528 of Maps, Page 25, records of Maricopa County, Arizona, located at 4901 South Ellsworth Road, APN: 312-17-958A, as hereafter described ("Public Utilities and Facilities Easement") is not necessary for public use and is no longer needed by the City.

WHEREAS, the City Council has determined that a certain right-of-way dedicated on the Map of Dedication for South Ellsworth Road, in Book 1528 of Maps, Page 25, records of Maricopa County, Arizona, located at 4901 South Ellsworth Road, APN: 312-17-958A, as hereafter described ("Right-of-Way") is not necessary for public use and is no longer needed by the City.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

<u>Section 1</u>: All rights of the City of Mesa in and to the following Public Utilities and Facilities Easement, as more fully described and depicted in Exhibit "A", are extinguished:

That certain Public Utilities and Facilities Easement located in the Northwest ¼, of Section 22, Township 1 South, Range 7 East, of the Gila and Salt River Base and Meridian, Maricopa County, Arizona and is more particularly described as follows:

PLEASE REFER TO THE LEGAL DESCRIPTION AND DEPICTION ON EXHIBIT "A" ATTACHED HERETO AND MADE A PART OF.

Section 2: All rights of the City of Mesa in and to the following Right-of-Way, as more fully described and depicted in Exhibit "B", are vacated:

That certain Right-of-Way located in the Northwest ¼ of Section 22, Township 1 South, Ranch 7 East, of the Gila and Salt River Base, and Meridian, Maricopa County, Arizona, is more particularly described as follows:

PLEASE REFER TO THE LEGAL DESCRIPTION AND DEPICTION ON EXHIBIT "B" ATTACHED HERETO AND MADE A PART OF.

Section 3: Pursuant to A.R.S. § 28-7205, title to the vacated Right-of-Way shall vest in the owner of the land abutting the vacated Right-of-Way (APN: 312-17-958A), subject to the same encumbrances, liens, limitations, restrictions and estates as exist on the land to which it accrues; provided, however, the City of Mesa hereby expressly reserves over, across, under, and upon the lands of the Right-of-Way property all rights in the permanent public utilities facilities easement granted to the City of Mesa by DMB Mesa Proving Grounds, LLC recorded in the records of Maricopa County on October 22, 2018 (Document No. 2018-0786966) and nothing in this Resolution shall be deemed an extinguishment, transfer, modification, or termination of such easement.

Thence North 89 degrees 44 minutes 52 seconds East a distance of 73.00 feet to a point on the east line of the existing 8.00-foot PUFE described in Maricopa County Recorder Document # 2018-0786966, said point being the POINT OF BEGINNING;

Thence continuing North 89 degrees 44 minutes 52 seconds East a distance of 13.00 feet to a point on a line parallel with and 86.00 feet distant from said West line of the Northwest Quarter, said parallel line also being the east line of said Parcel C;

Thence South 89 degrees 44 minutes 52 seconds West a distance of 21.00 feet to a point on said east line of the existing 8.00-foot PUFE;


