A RESOLUTION OF THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, ADOPTING A RULE FOR THE MAXIMUM DOLLAR AMOUNT FOR INDIVIDUAL JOB ORDERS UNDER JOB ORDER CONTRACTS PROCURED PURSUANT TO TITLE 34 OF THE ARIZONA REVISED STATUTES, AUTHORIZING THE CITY MANAGER OR HIS DESIGNATED REPRESENTATIVE TO APPROVE FUTURE JOB ORDERS CONSISTENT WITH THIS RESOLUTION; AND AUTHORIZING THE EXECUTION OF AN INDIVIDUAL JOB ORDER UNDER JOB ORDER MASTER CONTRACT MA-19003214 WITH A VALUE OF \$1,700,000.

WHEREAS, the City of Mesa finds that the use of Job Order Contracts procured pursuant to Title 34 of the Arizona Revised Statutes is an effective, efficient, and fiscally responsible method to contract for design and construction services for City infrastructure projects; and

WHERAS, Arizona Revised Statutes Section 34-605(F)(1) provides that public agencies may "adopt a rule" establishing a maximum dollar amount for individual job orders executed under a Job Order Contract; and

WHEREAS, at present, following Council approval of a Job Order Contract, the City Manager is authorized to enter into individual job orders consistent with such contracts, provided he notifies the Council of new job orders following their execution; and

WHEREAS, the Council has previously approved Job Order Contracts allowing for individual job orders with a value of up to One Million Five Hundred Thousand Dollars; and

WHEREAS, the Council finds that, where circumstances justify, the City may benefit from the limited approval of individual job orders in excess of One Million Five Hundred Thousand Dollars and up to Two Million Dollars; and

WHEREAS, the Council desires to adopt a rule concerning the maximum dollar amount for individual job orders, and to establish a procedure whereby the City may enter into individual job orders up to Two Million Dollars in value.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MESA, COUNTY OF MARICOPA, ARIZONA, AS FOLLOWS:

<u>Section 1:</u> That the City Manager or his designee is hereby authorized to approve individual job orders with a maximum dollar amount of up to One Million Five Hundred Thousand Dollars under Council-approved Job Order Master Contracts, provided that the City Manager notify the City Council of all new job orders following their execution; and

Section 2: That the City Manager or his designee may enter into individual job orders in excess of One Million Five Hundred Thousand Dollars and up to Two Million Dollars, provided that the City Manager obtains the Council's prior approval of the specific job order through a Council resolution; and

<u>Section 3:</u> That the City Manager or his designee is authorized to enter into an individual job order under Job Order Master Contract MA-19003214, valued at \$1,700,000 for build-out of approximately 10,000 square feet of space within a City-owned building located at 225 E. Main Street in support of an innovative educational partnership between Benedictine University and CO+HOOTS.
