### **Purpose and Recommendation**

The purpose of this report is for the Mesa Housing Services Governing Board ("Board") to review and approve the Fiscal Year 2021/2022 PHA Annual Plan. Staff is recommending that the Board adopt a resolution regarding the approval of the Fiscal Year 2021/2022 PHA Annual Plan.

## Background

The City Mesa Housing Authority prepared a Five-Year Housing Plan in April 2020 to the U.S. Department of Housing and Urban Development (HUD) which provides information on the City of Mesa Public Housing Authority and its goals and objectives from 2020-2024. The Annual Plan provides an update on the 5-Year Plan's goals and objective for assisting families in the City of Mesa with rental subsidy under the Housing Choice Voucher Program.

As part of the requirements for continued funding from the U.S. Department of Housing and Urban Development (HUD), the Mesa Housing Authority is required to prepare an PHA Annual Plan. The PHA Annual Plan informs HUD of the goals and objectives the City of Mesa Housing Authority will pursue during the upcoming year relative to specific program areas. The plan must be reviewed and approved by the Housing Governing Board before submission to HUD. The goals and objectives of the plan are to assist eligible families in the City of Mesa with rental subsidy in compliance with federal regulations.

#### Discussion

The 2021/2022 PHA Annual Plan has been drafted and attached for review and approval. The plans, attached and set forth, represent HUD's overall mission for housing authorities, which is "To promote adequate and affordable housing, economic opportunity, and a suitable living environment free from discrimination".

Staff has considered data from the Resident Advisory Board in the PHA Annual Plan FY2021/2022 on February 8, 2021.
