Subject: Dollar Limit Increase to the Term Contract for Motorola and Kenwood Radio

Equipment, Parts, Network and Services for the Mesa Police Department

(Citywide)

Recommendation

Council is requested to approve the contract amendment as recommended.

The Police Department and Purchasing recommend increasing the dollar limit using the State of Arizona and Maricopa County cooperative contracts with Motorola Solutions, Inc.; Durham Communications, Inc.; and JVCKenwood USA Corporation; by \$320,000 for Years 2 through 5, from \$700,000 to \$1,020,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

On 12/9/2019, Council approved this contract with the use of the aforementioned cooperative contract vendors for Information Technology - Communications to make purchases of Motorola and Kenwood equipment, repairs and services for various City Departments on an as-needed basis. This contract provides Motorola and Kenwood radios as another option for purchase and maintenance for City departments.

On 2/24/2020, Council approved a dollar limit increase for Mesa Fire and Medical to purchase new radio equipment for their new emergency response vehicles that are being purchased each year, and for additional equipment, repairs and services as needed.

The Police Department will be using this contract to purchase new mobile radios for Police vehicles that are being purchased each year, and for additional equipment, repairs and services as needed. Motorola provided Quote 1429820 on 3/5/2021 for 34, APX 6500's, related accessories, and licenses at \$221,567.87. The Department estimates additional equipment costs at \$98,000; one mobile radio for a grant funded vehicle for \$6,400, antennas for the real-time Crime Center for \$50,000, and funding for unanticipated purchases of \$41,600.

Adding the Police Department as a user department and the associated dollar limit increase will allow the Department to utilize existing Motorola and Kenwood cooperative contracts for their equipment, repair and service needs.
