Subject:	Three-Year Term Contract with Two Years of Renewal Options for Rotork and Halogen Actuators for the Water Resources and Parks, Recreation and Community Facilities Departments (Citywide)

Recommendation

Council is requested to approve the award as recommended.

A committee representing the Water Resources Department and Purchasing evaluated responses. The evaluation committee recommends awarding the contract to the responsive and responsible proposals from Chemical Feeding Technologies Inc. and TW Associates dba MISCOwater at \$305,000 annually, with an annual increase allowance of up to 5% or the adjusted Consumer Price Index.

Background / Discussion

This contract will provide Rotork and Halogen actuators, parts, maintenance and repair services needed to maintain critical water, wastewater and recreational aquatic facilities infrastructure.

Chemical Feeding Technologies is the exclusive representative for Halogen Valve Systems for Arizona. MISCOwater is Rotork Controls' sole authorized manufacturer's representative, and authorized to provide local service support for Rotork products, for Arizona and New Mexico.

The City received three proposal responses of which two vendors met the minimum qualifications; one vendor was deemed as non-responsive. The evaluation committee evaluated the proposal responses in accordance with the City's established policies and procedures and completed scoring of the responses against the scoring criteria in the solicitation. Based upon the evaluation results, award is recommended to both responsive and responsible respondents.
