A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA APPROVING AND AUTHORIZING THE CITY MANAGER TO ACCEPT PROPOSITION 202 FUNDS FROM THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY AND ADMINISTER AWARDED FUNDS AS PASS-THROUGH GRANTS TO DESIGNATED AWARDEES.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

Section 1: Arizona's Indian Gaming Compact provides that an Indian Tribe make twelve percent (12%) of its net annual State contribution to cities, towns or counties for government services that benefit the general public. Private, not-for-profit organizations wishing to access Indian Gaming Funds ("Gaming Funds") to provide public benefits must secure sponsorship from a city, town or county before making application. This sponsorship must be expressed in a resolution passed by the local government sponsor.

Section 2: The Salt River Pima-Maricopa Indian Community wishes the City of Mesa to receive and distribute \$1,420,000.00 from its 2021 12% revenues for grants as follows:

- \$200,000.00 to **A New Leaf** for shelter and support services.
- \$ 50,000.00 to **U.S. Vets** for mental health services for homeless and at-risk veterans.
- \$ 75,000.00 to the **Child Crisis Arizona** for prevention services.
- \$ 75,000.00 to **Bogden House** for the CMC Dignity Care Program.
- \$ 20,000.00 to **Visit Mesa** for the "Play all Day & Stay" fall and winter campaign highlighting outdoor recreation.
- \$125,000.00 to the **United Food Bank** for Mobile Pantry Emergency & Supplemental Food Assistance Program.
- \$300,000.00 to the **City of Mesa** to fund government programs.
- \$525,000.00 to the **Mesa Public Schools** for mental health wellness and social services support programming for students.
- \$ 50,000.00 to the **Alice Cooper's Solid Rock Teen Center** for the "Art Heals Program."

Section 3: The City Council supports these grants and authorizes the City Manager, or his designee, to accept and administer the 2021 awarded Salt River Pima-Maricopa Indian Community Proposition 202 funding.

Section 4: Approval by the City Attorney or designee and signature by the City Manager or designee of the Intergovernmental Agreement, and any related amendments or supplements thereto, shall constitute conclusive evidence of this City Council's approval thereof.
