Mayor's Welcome.

Mayor Giles conducted a roll call.

Invocation by Mark Anderson with Unification Church of Arizona.

Pledge of Allegiance was led by Mayor Giles.

Awards, Recognitions and Announcements.

There were no awards, recognitions or announcements.

1. Appointment of Joseph Lisitano as City Auditor.

It was moved by Councilmember Luna, seconded by Councilmember Thompson, that Joseph Lisitano be appointed as City Auditor.

Upon tabulation of votes, it showed:

Mayor Giles congratulated City Auditor Joseph Listiano on his appointment as the City Auditor and stated his appreciation for the hard work he continues to provide to the City.

Mayor Giles congratulated City Magistrate Stephen Umpleby and pointed out he has been an Assistant City Prosecutor for the City of Mesa since 2018.

#### 6. Take action on the following liquor license applications:

#### \*6-a. Palace Nail Lounge by Jimmy

A nail salon is requesting a new Series 07 Beer and Wine Bar License for Jimmy Nguyen, sole proprietor, 1940 West Rio Salado Parkway, Suite 101-102. This is an ownership transfer; therefore, the existing license held by Phoenix Blue Sky LLC will revert to the State for modification. (District 1)

#### \*6-b. Family Dollar Store #23914

A general merchandise retailer is requesting a new Series 10 Beer and Wine Store License for Family Dollar Inc., 255 East Southern Avenue, Suite 9; Ralphael Sean Piche, agent. There is no existing license at this location. **(District 4)** 

#### 7. Take action on the following contracts:

#### \*7-a. Ratification of the Emergency Purchase of Antigen Rapid Tests. (Citywide)

The City purchased 2,000 COVID-19 antigen tests on 12/29/2020. Antigen tests were needed as soon as possible to test Mesa Fire and Medical and Police upon their return to work after the holidays.

The Mesa Fire and Medical Department and Purchasing recommend ratifying the purchase with AllerCyte, at \$47,987.60. This purchase is funded by the Mesa CARES Program.

# \*7-b. Purchase of Fire Apparatus (Four Replacement Pumpers) for the Mesa Fire and Medical Department. (Citywide)

The four replacement pumpers are part of MFMD's ongoing apparatus replacement schedule and will be used as emergency response frontline units. The four apparatus that are being replaced are reserves and have met established replacement criteria and will be sold by a sealed bid process or traded-in as part of the City's fire apparatus purchase agreement with Pierce Manufacturing.

The City entered into a five-year fire apparatus Master Purchase Agreement with Pierce Manufacturing in 2014 and a three-year renewal in 2019. Staff is studying purchase options including apparatus brands for future purchases.

The Mesa Fire and Medical Department and Purchasing recommend awarding this purchase to Pierce Manufacturing Inc., through their designated local dealer, Hughes Fire Equipment Inc., at \$3,238,433.74. This purchase is funded by 2018 Public Safety Bonds.

\*7-c. Three-Year Term Contract with Two Years of Renewal Options for Landscape Maintenance Services for City Facilities (Secured Sites) for the Parks, Recreation and Community Facilities Department. **(Citywide)** 

This contract will establish landscape maintenance services for all applicable City facilities within the Secured Sites Zone which encompasses 22 City facilities.

An evaluation committee recommends awarding the contract to the highest scored proposal from Brightview Landscape Services, Inc., at \$251,000 annually (includes a 20% contingency), with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*7-d. Three-Year Term Contract with Two Years of Renewal Options for Landscape Maintenance Services for City Facilities (Zone 5) for the Parks, Recreation and Community Facilities Department. **(Citywide)** 

This contract will establish landscape maintenance services for all applicable City facilities within Zone 5, which encompasses 22 City facilities.

An evaluation committee recommends awarding the contract to the highest scored proposal from Mariposa Landscape Arizona, Inc., at \$347,444 annually (includes a 20% contingency), with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*7-e. Three-Year Term Contract with Two Years of Renewal Options for Landscape Maintenance Services for City Facilities (Zone 6) for the Parks, Recreation and Community Facilities Department. **(Citywide)** 

This contract will establish landscape maintenance services for all applicable City facilities within Zone 6, which encompasses 24 City facilities.

An evaluation committee recommends awarding the contract to the highest scored proposal from Mariposa Landscape Arizona, Inc., at \$419,764 annually (includes a 20% contingency), with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*7-f. Three-Year Term Contract with Two Years of Renewal Options for Landscape Maintenance Services for City Facilities (Zone 7) for the Parks, Recreation and Community Facilities Department. **(Citywide)** 

This contract will establish landscape maintenance services for all applicable City facilities within Zone 7, which encompasses 14 City facilities.

An evaluation committee recommends awarding the contract to the highest scored proposal from Brightview Landscape Services, Inc., at \$221,350 annually (includes a 20% contingency), with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*7-g. Purchase of Application Delivery Controllers Software and Support (Upgrade/Replacement) for the Department of Innovation and Technology. **(Citywide)** 

Application delivery controllers (ADC) balance the network traffic to City hosted websites and application services both on premise and in the cloud. They also provide secure access to websites and applications for employees, retirees, and customers. The ADC software licenses will retire current hardware ADC's, while increasing the capacity of existing software ADC's, and allow for ADC services in the City's cloud environment.

Department of Innovation and Technology (DoIT) and Purchasing recommend authorizing the purchase using the National Cooperative Purchasing Alliance cooperative contract and lowest quoted vendor, Sentinel Technologies, Inc., at \$89,491.67, based on estimated requirements. This purchase is funded by DoIT Lifecycle Program Budget.

\*7-h. 44-Month Term Contract with Five Years of Renewal Options for Kenwood Radio Equipment for the Water Resources Department. (Citywide)

This contract will provide replacement Kenwood radios as needed for Water Resources - Wastewater collection crews.

The Water Resources Department and Purchasing recommend authorizing the purchase using the State of Arizona contract with Durham Communications, Inc.; Southwest Radio Sales; and Kelly Communications, Inc., at \$60,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*7-i. Purchase of Leica Land Surveying Equipment (Upgrade/Replacement) for the Engineering Department (Sole Source). **(Citywide)** 

This equipment will be used to perform engineering plan reviews for surveying conformance, legal and easement descriptions, topographic surveys for engineering design and support, construction surveying services, regular maintenance and perpetuation of the Citywide benchmark system used for vertical control within the City, for various City Departments. To fulfill these requests, operational, accurate, and functional land surveying equipment is needed.

The Engineering Department and Purchasing recommend authorizing the purchase from the sole source vendor, Surveyors Source, at \$60,053.57.

- \*7-j. Authorizing the Mayor to sign an employment contract with the City Auditor.
- \*7-k. Authorizing the Mayor to sign an amendment to the employment contract with the City Clerk.

#### Items not on the Consent Agenda.

9-h. Amending Title 6 of the Mesa City Code (Police Regulations) by repealing Chapter 14, entitled "Fair Housing," in its entirety, and adding a new Chapter 14 entitled "Non-Discrimination Code," prohibiting discrimination in public accommodations, employment, and housing on the basis of race, color, ethnicity, national origin, age, disability, religion, sex, sexual orientation, gender, gender identity, veteran's status, marital status, or familial status, with certain exclusions. **(Citywide)** 

Ron Williams, a Mesa resident, believes if the City adopted the NDO, it would further the truth that Mesa is a strong community where residents, businesses, and visitors are treated with dignity and respect. He urged Council to support and vote in favor of the proposed NDO.

Bryce Cook, a Mesa resident, spoke in support of the proposed NDO to ensure equal treatment and protection for all Mesa citizens. He stated that no one should have to live in fear because of who they choose to be.

Shane Cooper-Blissett, a Mesa resident, indicated support for the NDO and explained the ordinance is of the utmost importance to ensure that the community is not discriminated against in public spaces, employment, and housing. He added with the proposed NDO, Mesa could see an influx of lesbian, gay, bisexual, transgender, queer/questioning (LGBTQ) citizens that would bring more culture and dollars to the City.

Tamara Staas, a Tempe resident, who teaches for Mesa Public Schools stated she has two son's who are a part of the LGBTQ community and the NDO would help support and protect the LGBTQ community in Mesa. She mentioned many people are concerned with safety, and other cities and towns that have passed an NDO have seen no increase in incidents.

Marcie Hutchinson, a Mesa resident, explained the NDO is the City's promise that we are an inclusive, thriving community where all people are welcome in schools, neighborhoods, stores, restaurants, and more without the fear of discrimination based on disability, religious beliefs, ethnicity, race, or gender identity. She strongly urges Council to support the NDO.

Ginger Hamp, a Mesa resident, spoke in support of the ordinance commenting that Mesa needs to state loud and clear that if a business wants the privilege of doing business in Mesa, then discriminating against one employee or person is one too many. She added allowing for leniency illustrates it is acceptable for small businesses to discriminate.

Christiana Hammond, a Mesa resident, stated she is in support of the NDO and is speaking from experience as she is transgender herself, with two young children. She explained aside from taking her children to and from social activities, she tries to not be visible because of being different and that there are not a lot of LGBTQ people that she knows. She noted if the proposed NDO is approved it will make her and the LGBTQ community feel more comfortable and accepted by the community.

Verl Farnsworth, a Mesa resident commented that 99% of US cities do not have non-discrimination ordinances. He asked what criteria led to such a policy, that having a policy in place has not kept businesses from coming to Mesa, that Council has already admitted this is not a big issue in neighboring cities, and that this effort should be abandoned.

Todd Wilson, a Mesa resident stated comments in favor of the NDO have focused on the statutes and the civic virtues of Mesa residents. He explained the law is meant to provide a structure for

government and is not a declaration of morals or virtues. He pointed out that in other jurisdictions instead of protecting minorities from unjust discrimination, NDO's have sacrificed the privacy of women. He encouraged Council to focus on a policy that would address issues as they are identified.

Jacob Brown, a Mesa resident commented that he does not believe all people are being protected in this ordinance, and by focusing on compliance and not diversity, Council missed the chance to have an important discussion on making lives better. He stressed the need to value diversity, focus on making jobs, housing, and services available to everyone. He suggested there are significant problems with this ordinance, that it does not provide the proper balance and that a better ordinance should be considered.

Larry Blomquist, a Mesa resident stated the opinion that the NDO is flawed in that gender identity is defined, changing the historical and established definition of gender by replacing biology with psychology. He remarked the consequences of enacting the NDO have not been given sufficient consideration and urged Council to reject this ordinance or strike all references to gender identity.

Cathi Herrod, an attorney with the Center for Arizona Policy stated even with the exclusions, the NDO creates significant problems, including approving one gender to enter gender specific showers, locker rooms, bathrooms etc. of the opposite gender; and the exclusionary language from religious activity is vague and undefined. She urged Council not to pass the ordinance and submit it to the voters.

David Land, a Mesa resident commented that today individuals have the right to be what they want to be and because of this philosophy we are seeing more and more perversion in our nation and now the governing body for the City wants to open a pandoras box of legal problems. He encouraged Council to vote against this ordinance.

Karen Gevaert, a Mesa resident expressed concerns regarding safety and privacy for women and stated the NDO should not be approved.

The speakers offered a series of comments including, but not limited to, the following:

- The NDO should keep employment regulations to one or more employees.
- The new code will help Mesa attract and retain business, tourism, and residents.
- The NDO enhances Mesa's image as a city that cares about its resident's wellbeing.
- The NDO helps protect our residents and sends a message that Mesa is a place that has values and welcomes diversity.
- The ordinance is about equal treatment, not special treatment.
- A Mesa that respects and protects all people is not only the right thing to do, but it is also good for the business of our City.
- Any action the Council can take to help ensure fair and non-discriminatory practices in Mesa is critical and important.
- Supporting the NDO in Mesa would make me prouder to raise my children here.
- Treating people fairly is the foundation of a stable and strong economy and supporting the NDO will help attract quality applicants for hiring and making customers more comfortable spending their dollars locally.
- The adoption of the NDO will highlight the fact that Mesa is a strong, unified community where residents, businesses and visitors are respected.
- Ensuring that equal opportunities will become a reality for all of Mesa's residents.

The speakers offered a series of comments including, but not limited to, the following:

- There are many reported cases of sexual assault and abuse by sexual predators on children and women in public restrooms, locker rooms, and women's shelters in cities that prohibit discrimination in public accommodations and housing based on gender identity.
- Women's shelters cannot deny men identifying as a woman.
- The NDO undermines constitutional freedoms of speech and religion.
- Concerns that the NDO will be used to punish and/or marginalize families of faith.
- Instead of adopting the NDO, defend the First Amendment and inalienable rights of all persons.
- The portion of the proposed NDO that needs revision are bathrooms, locker rooms, and dressing room facilities.
- The NDO is unfair to children and could put them in a situation that could cause them danger or harm.
- Demonstrate through local ordinances and codes that all people in the community are valued and cared for.
- This NDO will take away all privacy in boys and girl's bathrooms in schools.
- The NDO opens the doors for child predators, sex offenders, and for child trafficking.
- This is a dangerous ordinance because perception is not reality and laws should not be passed based on perceptions but on facts and sound judgement.
- Violation of privacy

Mayor Giles expressed appreciation for the participation on both sides of the NDO, and that Council will do their best to thoughtfully respond to residents.

It was moved by Vice Mayor Duff, seconded by Councilmember Luna, to introduce the Non-Discrimination Ordinance and set the public hearing as March 1, 2021 with an amendment to the definition of employer by striking the phrase 15 or more employees and inserting the phrase five or more employees.
